2013 was a great year for the Foundation and it was their largest year ever in fundraised dollars. Due to this great community support, the Foundation has decided to make the following investments in support of quality cancer care in our region:

\$598,801

Used to fund 100% of Support Services, including the \$43,753 overage due to increase breast screening provided to our community.

\$63,464

Used for the initial acquisition of the MIMS software program to better integrate imaging from outside facilities, aiding in more accurate treatment planning.

\$33,000

Used to purchase the Eclipse Treatment Planning Software.

\$55,000

Used to fund the first year of fees for Seattle Cancer Care Alliance Network Membership. Providing our community with advancing specialized care and treatment options for patients and access to clinical studies for targeted cancer therapies, even before they may become widely available.

\$24,151

Used to upgrade and improve the treatment capabilities for our BrainLab System, used in stereotactic brain treatments.

\$22,187

Used to purchase an HDR device to provide more accurate treatment to patients who are battling uterine and cervical cancer.

\$355,670

Invested in the Foundation's endowment. This brings the Foundation's Endowment to over \$2.5 million.
